Kindly adhere to all guidelines and prerequisites during the registration process. This covers formatting requirements (such as font sizes, margins, and page counts). If you don't follow these guidelines, your application might not be evaluated favorably and might even be withdrawn.

Registration submission

The Nominated Principal Applicant must review and agree to the general conditions and consent to disclosure of personal information terms, presented on [ResearchNet](#), before they can submit the registration to CIHR.

There are no signature pages required as part of the registration submitted to CIHR. The Nominated Principal Applicant must click Submit to send the registration to CIHR.

Note that the application will open once your registration has been submitted.

Applications to the Project grant program must be electronically submitted using the [ResearchNet](#) portal. Please read the application instructions carefully before starting your grant application.

Full Application Submission

- The [eApproval process](#) procedure is followed for Project Grant submission. This implies that the application will be sent electronically to the institution the applicant has designated as the Institution Paid when it is submitted.
- On behalf of the applicant, The Institution Paid will examine the application and electronically transmit their approval to CIHR. It is critical to understand the internal deadline set by your institution.
- Applicants must use the UBC Research Project Information Form ([RPIF](#)) available on the Office of Research Services (ORS) [website](#) to obtain required signatures. UBCO e-submission deadline [September 10, 2024, 12:00 pm PT](#).

Full Application Criteria & Editorial review

- For guaranteed criteria and editorial review, send full application in Microsoft Word or similar to joyceline.amoako@ubc.ca by Due [August 23, 2024](#).
- Materials received after [August 23, 2024](#) will be reviewed based on availability or given quick scan through for formatting issues and completeness.
