- If you would like to discuss reviews, please send the entire Notice of Decision package (PDF format) including score, ranking, reviewer comments, and Scientific Officer notes (if available) to [denise.maines@ubc.ca](mailto:denise.maines@ubc.ca) by January 19, 9:00am.
- You do not need to have written your response to reviews at this time.
- I will review all documents received and set up a meeting to discuss, using templates provided by SPARC. You are welcome to submit your response to reviews with your other application materials when you submit your documents for review.

### Peer Review Committee Selection

- If you are unsure about the peer review committee you should select, please reach out to me before the final week of January, and I'll work with colleagues at SPARC to ensure you have expert advice.

### Criteria/Editorial reviews

Criteria/Editorial review: We are offering 'appointments' to review applications. We will provide suggestions around alignment to evaluation criteria (criteria review), and as capacity permits, we will also provide suggestions on flow, structure, syntax and grammar (editorial review).
